**The Caucasus Journal of Social Sciences (CJSS)** invites submissions for a forthcoming special issue titled Business, Economics and Governance (BEG). This special issue seeks to publish high-quality, original scholarship that addresses contemporary developments at the intersection of business systems, economic performance, and governance structures across regional and global contexts.

As economies face accelerating technological change, geopolitical uncertainty, sustainability pressures, and institutional transformation, the need for rigorous interdisciplinary research has become increasingly urgent. - Anti-corruption mechanisms and transparency systems

## Regional Relevance and International Perspective

While the special issue welcomes submissions from all geographical contexts, particular interest is given to research concerning the Caucasus, Black Sea region, Eastern Europe, Central Asia, and other emerging or transitional economies. Comparative studies linking these regions to broader global developments are especially encouraged.

### Submission Categories

The journal welcomes the following manuscript types:

All submissions must present a clear scholarly contribution and engage meaningfully with relevant international literature.

## Editorial and Peer Review Process

All manuscripts submitted to this special issue will undergo an initial editorial screening followed by a double-anonymized peer review process conducted by subject specialists. Acceptance decisions will be based on originality, analytical quality, methodological soundness, significance of findings, and relevance to the scope of the issue.

Submissions must not be under consideration elsewhere or previously published in any language.

### Author Requirements

---

Authors are expected to ensure that manuscripts:

- Demonstrate originality and intellectual contribution
- Apply appropriate and transparent methodology
- Present clearly structured argumentation and findings
- Follow recognized standards of publication ethics
- Include complete and accurate references
- Disclose funding sources and conflicts of interest where relevant
- Be written in high-standard academic English

Where applicable, studies involving human participants, surveys, interviews, or confidential data should include evidence of ethical approval.

In addition, all manuscripts must fully comply with the submission, formatting, ethical, referencing, and publication requirements published in the official Author Guidelines of The Caucasus Journal of Social Sciences (CJSS). Manuscripts that do not meet these requirements may be returned to authors prior to peer review.
